3. Please describe the proposed internship goals, scope, and objectives.

The goal of this internship is to focus on collecting and interpreting accurate data from 4-H youth, families, and volunteers by evaluating the content and structure in surveys, and then the process or software program used to interpret the data for stakeholders. 4-H Extension Agents, Emily Tobler & Charity Cagle, have been working to identify an effective measurement tool that would assist in identifying gaps, positive outcomes, and learning objectives in 4-H programming.
